### Terms and Conditions

### Late Payment Policy

1. Notice. After 1 week of account delinquency I will be informed through email by front office of penalty and late fee realization. I understand that failure to pay my dues could affect my player status on the team.

1. Lose eligibility for payment plan. If I fail to pay my installments on time on more than one occasion, then I will not be eligible for a payment plan the following semester.

1. Readmission withholding. If I have any outstanding balance, then I will not be able to enroll for future payment plans until I fulfill my obligation.

I agree, and have read and understood all the above terms and conditions. I hereby agree to this payment agreement schedule for charges incurred at Rise as one/ The House of Sports until my account balance is paid in full. My failure to make payments without notification to the front office department at The House of Sports may result in further collection action. The House of Sports will have full discretion for unpaid accounts and will take necessary legal actions to collect any unpaid balances.

There are two options for paying the Rise as One AAU Registration Fees. You can pay prior to each month that the player is participating in the Rise as One AAU program or you can pay for the entire season now.

### **OPTION PLAN A**

If you elect to utilize the payment plan option (A) you authorize the Rise as One AAU Program to charge your credit card in equal, monthly payments on April 5th, May 5th, and June 5th. Monthly processing fee will be included. This option will spread the total invoice amount (Registration Fee) over 3 monthly payments.

### **OPTION PLAN B**

If you elect to utilize the payment plan (B) you will provide Rise as One with 3 postdated checks to be deposited on April 5th, May 5th, and June 5th for the set amount of the level your player plays. Please make out check to The House of Sports
